The Livonia project has faced numerous rain delays. A revised schedule of completion will be presented by the next Library Board meeting. Issues facing the structure were discussed and recommendations were presented to remedy the various situations.

Mrs. Hymel presented a January memo to all employees outlying the basic responsibilities and expectations of their job duties.

State Library of Louisiana Staff Day will be held Tuesday, February 11, 2020. The library closed all facilities to allow staff participation in this training program.
